## Agency level:

- Participating in the co-leadership
- Managing / co-managing the QA expert pools
- State of play of capacity building activities and promoting Student participation in QA processes

## External QA

- Students' participation in the panel reviews
- Student - assessed criterias and responsibilities

## Internal QA:

- Understanding and promoting the Quality Culture
- Assessment of programmes, participation in the internal QA committees etc.
- Awareness regarding the impact and results of evaluations, given to the students
